Dear Friends,

Desiring in our Lord and Saviour Jesus Christ that you are enjoying the rich blessings shed abundantly over you. Receive a greeting from Dominican Republic.

Who writes is Pastor Missionary Neftali Lopez Bautista, together with my wife and our three children. We are found serving the Lord in the country before mentioned for more than 10 years. We are sent by the Iglesia Bautista Fundamental Independiente "Puerta Abierta" in Oaxaca, Mexico. Our pastor is called Joel Herrera. God in His grace has blessed us as a church and has let us grow and now we have the need as a church for more space. Our actual property has an area of 128 square meters of which all this area is located the temple where we actually meet.

The children meet in a borrowed property, but we don't count with enough place for Sunday School rooms, nursery, place to park vehicles and sufficient place to have attendance campaigns. We have learned to work adjusting as much as possible.

With this information in mind, I want to share with you also an offering to acquire a property with the following characteristics:

1. *It has an area 3 1/2 times more bigger than we actually have.*
2. *It has a constructed part with a special room for Sunday School class.*
3. *The property is in front of the main street.*
4. *The property is 2 minutes where we are actually are.*
5. *Has access to services like water and electricity which are the most basic services.*

This property has an area of 435 square meters. (With this property, we can cover many needs that we actually have as a church.)

The price of this property is of \$18,000 dollars and the price is negotiable, probably its final value is in the \$17,000 dollars. The motive of this letter is to solicit your help. First in prayer then like we know in spite for us is impossible to save this quantity of money, we know and believe that God can make a great miracle to save this sum of money.

Second, we know that God uses means to bless others. If you like to support us in this need, for us, it will be of great blessing and you as a church will have part in this need that now we have.

About a week ago, I spoke with the owner of the property and I ask three weeks so we can speak again and make an offer. That is the reason that when I speak with him again, I will propose that in two months I will give a part of what He has asked for the property and the rest to pay it in parts.

My plan is in 2 1/2 weeks (with the help of God and the generosity of His people) we can together save the most that we can, so the rest won't be a very big debt.

We as a church are excited and we are coordinating to make different activities so we can find funds and if we make our part, God will make His. With more for the moment, I leave you, thanking your time to read this letter. God bless you abundantly. I leave you,
